(Benjamin Horne)

- Charter Board Metrics
  - Met all of the charter financial metrics for FY2023.
  - Net Income & Debt Ratio up due to actual Net Increase in Assets being much higher than projected.
  - Unrestricted Days Liquidity was higher due to employee retention credit.
- Variance Report
  - Total variance of \$132k.
  - Increased from FY22 which was \$88k.
- Financial Statements
  - Without Employee Retention Credit, Increase in Net Assets was \$408k. This is a \$126k increase from FY22 (\$282k).
  - Restricted Net Assets of \$69k includes unspent CSF (34k) & NSLP (36k) funds.
  - Very strong balance sheet with over \$1.55M in Unrestricted Net Assets.
